## Registration Fees

## **Fixed and Variable Costs**

Fees are include both Fixed and Variable costs.

A fixed cost is a cost that does not change with an increase or decrease in the amount of goods or services produced or sold. Fixed costs are expenses that have to be paid by the association, independent of any specific business activities.

The Fixed Costs are budgeted for and then divided by the estimated number of teams. These costs are shared equally between all AMHA teams, regardless of stream. Fixed costs include:

- Office Operations (postage; paper; telephone; internet; scheduling software; website hosting fees; accounting software; training, insurance etc)
- Development (coach reimbursements; player and goalie development)
- Professional Fees (Accountant and Payroll)
- Equipment (storage locker; pucks; first aid kits; jerseys; scorebooks etc)
- Wages and Consulting

2020-21 Season Fixed costs were estimated to be \$443K

Estimated revenue items are used to offset these fixed costs, including condition camps, tryout fees and tournament revenue. These were estimated to be \$104K, for a net fixed cost of \$338K / 84 teams = \$4,025/team



## Registration Fees

## **Fixed and Variable Costs**

A variable cost is a teams expense that changes in proportion to a teams use of that expense. Variable costs increase or decrease depending on a teams expected use of these variable expenses volume. Variable costs are different for each stream and division and costs differ for each team. Variable costs include:

- Ice costs (practices & estimated regular season home games
- Ref Fees
- Jerseys (Rec)
- Hockey Alberta Team Fees
- Hockey Alberta and Hockey Canada Player and Coach Cards
- Tournament Fees (new in 2020-21)
- Conditioning Camps that are now required by HA for U7-U11
- Try out costs
- League Fees (RHL, CAHL, SCHAL, AEFHL, AFHL, RMFHL)
- Specific development (ie U9 Power Skating)

NOTE: Conditioning Camps and Tryout Revenues are used to offset the expense, but vary from team to team.



## Fixed Expenses

## Fixed Costs 2020-21

Fixed Expenses for the 2020-21 Season are \$292K – a reduction of \$151K than estimated. The \$50K savings was achieved through several board initiatives:

Staff Reductions

Elimination of Bookkeeper

**Reduced Expenses** 

As well a reduction in planned development that could not be delivered, \$100K.

#### Variable costs are:

- Ice for practices and home games
- Referees
- League fees
- Hockey Alberta and Hockey Canada Fees
- Tryout Fees
- Tournament Fees

These fees change by stream and division

In addition, items are planned by team for :

- Ref Assigning Fee
- Jerseys (Rec)
- Power Skating (Novice)

Reductions from Hockey Alberta and Hockey Canada have been passed onto our members.

Ref Assigning fees have been negotiated to 10% of the usual fee per team.

## **Cash Impact**

#### Our current cash assets total \$1.1M. The most liquid assets are our operating bank account and the CEBA Loan Account. The AGLC Account are restricted funds and \$36K is due to AA teams over the next three years. \$40K of the Covid Loan amount must be paid back by December 2022.


The \$32K Accounts Receivable is the amount of unpaid fees.

The liabilities are amounts we owe but have yet to receive invoices for, as well as an estimated 5 months of expenses to ensure we have enough cash to cover February to June

The Refund cash impact totals \$717K, less unpaid fees and subsidies

# **Next Steps**

## **Credits and Refunds**

The default will be a credit on your registration for next year. You do not need to do anything to receive your credit.

However, members are welcome to a refund if they so choose. To receive the refund please email Cindy at <u>officeadmin@airdriehockey.com</u>. If you opt for a refund it will be via SportsEngine if the data is current, else a cheque or etransfer.

Please be patient as Cindy is processing the refunds and credits by herself.

## Incomplete Fees and Subsidies

Please note if did NOT pay registration fees in full or received a subsidy, you will receive the amount less any unpaid fees or subsidy.

For example, registration fees were \$1,560 paid in installments of \$75 and three payments of \$318.33 but the final \$530 due upon team placement remains unpaid. The credit/refund amount is 64% of the total registration cost, or \$1,000 but \$530 was not paid, the refund amount will only by \$470. Credit/refund will be the % of the total registration cost less unpaid fees and/or subsidy received.



# **Next Steps**

### 2021-22 Season

- Hopeful for a (somewhat more) normal season
- Have fees start later in the season, spread over several months
- Refunds will still be available after the deadline of February 23<sup>rd</sup>, but will need to be processed in a different way
- Tryouts will be required again as athletes will be changing divisions
- New Registration site, RAMP
